

RESCARE 2024 Cultural Programme: Guideline and Fees

Whether you excel in dance, acting, or any form of performance art, IARC provides the perfect stage for you to flaunt your best moves and exhibit your prowess.

NOTE: Following rules and regulations have to be followed for the competitions, if not the performance will get disqualified.

1. GROUP DANCE

- Each group should contain **minimum of 5 and maximum of 10 members**.
- Maximum time allotted for each group is **seven minutes**.
- **Negative markings** for exceeding the time limit.
- Choice of songs is open to the participants.
- Participants are requested to bring songs either in CD's or USB.
- Costumes and if any properties for dance has to be arranged by the dance team itself.
- The decisions of judges will be last and final (judged based on costume, visual presentation and performance).

2. MIME ACT

- Theme: **Role of respiratory therapists in various sectors**.
- First **five** groups who have registered for mime will be selected.
- Each group should consist of **5-10 members**.
- Maximum time limit **seven minutes**.
- Participants are requested to bring background scores either in CD's or USB.
- Be kind and courteous in the whole act.
- No hate messages and bullying in the act.
- Respect each one's privacy.
- Keep things crafted and related.

3. SOLO DANCE

- There should **only** be **one** participant from each college.
- Maximum time limit for a participant is **4-6 minutes**.
- Choice of songs is open to the participant.

- Participants are requested to bring songs either in CD's or USB.
- Costumes and if any properties have to be arranged by the participants.
- The decision of judges will be last and final (judged based on costume, visual presentation and performance).

4. SINGING (Solo)

- Duration of performance: 2 to 3 minutes. Exceeding the time may lead to a
- deduction in marks
- Cinema songs are allowed.
- Singers may use a karaoke track or Instruments.
- Use of vulgar, sexually explicit, violent language and/or lyrics is strictly prohibited.
- The participant may submit only one song with registration (per person). The
- category for the song has to be selected at the time of registration.
- Judgment is on the qualities like Swara, Taal and selection of song, composition and overall impression.
- The contestant should be dressed appropriately during the Performance. Indecent exposure is NOT allowed.
